Tangem Newsletter Subscription Competition Terms and Conditions

1. Introduction

These Terms and Conditions apply to the Tangem (Tangem AG, a company incorporated and acting under the laws of Switzerland) Newsletter Subscription Competition (the "Competition") and govern individual's (hereinafter "you", "your", "yours", "participant") participation. By submitting your email and subscribing to Tangem newsletters through the designated form on our website, you agree to be bound by these Terms and Conditions and Privacy Policy available at Tangem website.

2. Eligibility

To enter the Competition, You must:

- Be at least 18 years old.
- Provide a valid email address through the subscription form on Tangem's official website.
- Agree to receive newsletters from Tangem.
- Comply with all relevant laws and regulations in your country of residence.

Only one unique email address is allowed per participant. Duplicate entries using the same or different email addresses will result in disqualification.

3. How to Enter

To participate in the Competition:

- Submit your email address in the subscription form on the Tangem website.
- By subscribing, you will automatically be entered into the Competition.
- After subscribing, each participant will receive a confirmation email containing a unique personal ID.
- If a participant submits their email address multiple times, **only the last assigned personal ID** will be eligible for the Competition.
- The personal ID will be used to determine the winner during the Tangem live stream.

The Competition starts on **1st of April and ends on 30th April 2025**. Entries received after the end date will not be eligible.
