

Tangem BTC & Match Tickets Giveaway — Terms and Conditions (March 2026)

1. Promoter

This promotion (the “Promotion”) is organised by Tangem AG (the “Promoter”).

2. Eligibility

- The Promotion is open to individuals aged 18 years or older at the time of entry.
- Employees of the Promoter and their immediate families are not eligible.
- The Promotion is void where prohibited by law.

3. Promotion Period

The Promotion runs from 1st April 2026 to 31st July 2026 (the “Promotion Period”).
Entries received outside this period will not be valid.

4. How to Enter

To enter:

1. Visit the official [Promotion landing page](#);
2. Submit a valid email address;
3. Confirm your email address via the link on confirmation email sent to you.

Only confirmed email addresses will be entered into the Promotion.

- One entry per person (duplicate entries may be disqualified).
- No purchase or payment of any kind is required to enter or win.

5. Prize Structure

5.1 BTC Rewards

A total prize pool of 1 BTC will be distributed across multiple prize tiers, including:

- 1 × Grand prize (0.15 BTC)
- 5 × Gold prizes (0.03 BTC each)
- 25 × Silver prizes (0.008 BTC each)
- 100 × Bronze prizes (0.002 BTC each)
- 300 × Lucky Draw prizes (0.001 BTC each)

(Exact BTC amounts may be subject to rounding adjustments.)

5.2 Match Tickets

A number of match tickets (up to 50 tickets) will be awarded to selected winners.

Important:

- Tickets are sourced via third-party providers.
- Ticket allocation, seating, and match selection are determined at the Promoter’s discretion.
- Winners may be required to provide personal information to facilitate ticket allocation.

6. Winner Selection

- Winners will be selected at random from the pool of valid, confirmed entries.
- Draws will take place:
 - Weekly during the Promotion (for certain prize tiers);
 - Mid-campaign (for selected tiers);
 - At the end of the Promotion (for the Grand Prize).
- Prizes may be awarded and distributed on a rolling basis throughout the Promotion Period.
- The Promoter’s decision is final.
- The Promoter reserves the right to adjust the timing and distribution of prizes during the Promotion Period.

7. Winner Notification

- Winners will be notified via email.
- Winners must respond within 5 days to claim their prize. If a winner does not respond within this timeframe, the Promoter reserves the right to forfeit the prize and select an alternative winner.

8. Prize Delivery

8.1 BTC Prizes

- BTC rewards will be delivered via QR codes, promo codes, or equivalent mechanisms. Codes must be redeemed within 90 days of issuance or they will expire.
- Instructions for redemption will be provided to winners.

The Promoter is not responsible for:

- incorrect wallet details provided by the winner;
- failure to redeem within specified timelines.

Winners are solely responsible for all applicable taxes, including income and capital gains taxes, arising from the receipt of BTC rewards.

8.2 Tickets

- Winners may be required to provide identification details for ticket issuance.
- Ticket delivery method will depend on the ticket provider (e.g. digital transfer, app-based ticketing).

Match tickets are subject to availability and timing constraints.

All match tickets will be distributed prior to the start of the relevant matches. Once matches have commenced, no further match ticket prizes will be awarded.

The Promoter reserves the right to allocate ticket prizes at its discretion through the Promotion Period and to substitute ticket prizes with alternative prizes of equal or greater value where necessary.

Additionally, the Promoter does not guarantee:

- specific matches;
- specific seating;
- ability to transfer tickets outside official channels.

9. Important Disclaimers

- The Promoter is an independent entity and is not an official sponsor, partner, or affiliate of any football tournament or governing body. Match tickets are sourced through authorized secondary market channels and are not provided directly by tournament organizers
- The Promoter is not responsible for:
 - ticket validity issues arising from third-party providers;
 - event cancellations or changes;
 - travel or accommodation costs.

10. Data Protection

- By entering the Promotion, participants agree that their personal data (email and, if applicable, identification details) will be processed:
 - for the purpose of administering the Promotion;
 - for contacting winners;
 - and as described in Tangem's Privacy Policy.
- Data may be shared with third-party providers where necessary to fulfil prizes (e.g. ticket providers).

11. Disqualification

The Promoter reserves the right to disqualify any participant who:

- submits false or misleading information;
- uses multiple identities or automated entries;
- breaches these Terms.

12. Limitation of Liability

To the fullest extent permitted by law, the Promoter shall not be liable for:

- any loss, damage, or injury arising from participation in the Promotion;
- technical failures, including email delivery issues;

- loss of crypto assets due to user error or external factors.

13. General

 - amend or cancel the Promotion where necessary;
 - substitute prizes of equal or greater value.
